The Board needs to see how the projects will be broken down and not happy with engineering and design as her calculation is \$300,000 minimum for transfer station relocation and now would like to table this until tomorrow.

Vicky Carey stated her question is the BOF had a Capital Improvement Policy which the Town Council did agree with many years ago and has the Capital Improvements Committee seen the bond package, do they agree with it and does it meet guidelines on the 5 year capital improvement plan. They are main source for all capital improvements and they should be actively here. Mayor Merchant stated he will get her the information.
