5. Begin pass-through of Budget: General Fund Revenue/Debt Service

Grace K. Zweig - Finance Director stated will not cover property and motor vehicle taxes.

Jim Kilduff stated will have the Tax Collector Pam Pelletier here for a report on March 9, 2023.

Grace K. Zweig stated have received numbers from the State for the grants and the ECS grant dropped \$100,000 in the budget is and supposed to be dropped another \$100,000 next year.

Jim Kilduff stated hopefully will stay at the current level, a whole new calculation.

Eugene Croce stated putting more money in - changing the formula and briefly elaborated.

Briana Brumaghim stated wondering if it's part of their push to encourage towns to regionalize.

Grace K. Zweig, Finance Director stated motor vehicle property tax cap grant was calculated last year it was a lot higher that's also going to be dropping around \$250,000 (not final might change) and briefly elaborated.

Vicky Carey questioned on page 4 investment incomes went down \$20,000

Grace K. Zweig, Finance Director stated that based on actual (2022) - only \$15,000 dropped it.

Briana Brumaghim questioned how the town funds are invested and how often that's reviewed for different options.

Grace K. Zweig, Finance Director stated currently working on cash accounts -limited as to what we can invest in as a municipality – mostly savings, checking, and CDs.

Briana Brumaghim stated must have to be very conservative.

Grace K. Zweig, Finance Director stated our goal is to consolidate accounts and some need to be segregated, once consolidated leverage balances to get better rates which I was able to do.

Briana Brumaghim questioned proposed increases for the town clerk's office and the building department noted 2022 actuals, inflated due to covid impact which is starting to dwindle.

Grace K. Zweig, Finance Director stated will follow-up – up when the department representative is present.

Grace K. Zweig, Finance Director stated re. pg. 16 debt service -a brief discussion took place regarding debt service.

Vicky Carey questioned the last bond taken out was in 2019.

Grace K. Zweig, Finance Director confirmed yes.

Eugene Croce questioned the Board of Education Sinking Fund -lapsing.

Jim Kilduff stated back to the original agreement, sinking fund design and accounting, and briefly elaborated. (Follow-up with the Board of Education)
