V. HUMAN SERVICES REPORT

Energy Assistance: Only \$200 left out of \$10,000 Operation Fuel has allocated. Need to review and update Energy Assistance policies and procedures for 2015. No changes recommended. With Charity Tracker, it will be very simple to determine who has gotten help and how much they have gotten.

DSS: Employment and Training – See attached article.

CLASS: (Connecticut Local Administrators of Social Service)

Town has paid for one person to attend the following upcoming trainings:

March 19th - Energy Assistance Updates

April 16th - Salvation Army Programs

May 21st - Supposed to be CT Pardon Process but they haven't found speaker yet.

June 18th - Diversity and Cultural Responsiveness

<u>Budget</u>: Mayor did not support commission's recommendation to add additional staffing – the recommendation is a 0% increase.

It is critical that people speak out about the importance of adding staff to the Human Services Office.

Under previous administration, the mayor's office covered for Human Services. With two less staff in the mayor's office, they are not able to do this.

Expecting one person to do everything with no back up is unreasonable.

Other towns that are similar to size, economics, mill rate, etc. have 2-3 times the size budget as Plymouth for their human/social services. Budget being presented to Finance Committee on March 23rd.

<u>Dial-A-Ride</u>: Some talk of joining Thomaston, but Thomaston has decided not to at this time. Grant is due March 20th. Interim finance director, AnnMarie Rheault will handle paperwork to continue receiving the grant.

AARP Driving Class: Scheduled for June 12th. Informed coordinator to contact human services in mid-April to coordinate with new director.

<u>Hospice Fund</u>: Gift cards for Seniors – CVS has a special type of card that only be used for health care related items (medications, over the counter, first aid, diapers etc.) still waiting for Finance Department to add CVS as a vendor. Rite Aid does not allow gift cards to be used for prescriptions so you may not want to use them.

Path to Employment for SNAP recipients

If you are receiving SNAP (food stamps) and not receiving financial assistance from the state of CT you may be eligible to participate in an exciting opportunity! SNAP Employment and Training offers many certificate and job training programs at no cost!

While the SNAP program meets the immediate need of hunger, the Employment and Training Program is designed to break the cycle of poverty. Most people receiving SNAP benefits who are able to work want to work. Many of SNAP recipients are working at jobs that don't pay high enough wage or provide enough hours. Employment and Training provides an opportunity for people to obtain certificates in a variety fields including but not limited to massage therapy, culinary arts and manufacturing.

In order to apply for this program, SNAP recipients can contact any of the 11 partners to enroll in the Employment and Training certificate program. The two closest colleges are Northwestern CT Community College 860-738-6419 (Winsted) or Capitol Community College (Hartford) 860-905-5029.

All eleven have entered into agreements with DSS to help eligible SNAP recipients gain the skills they need to find employment in the current job market. All eleven do their own recruiting and will be happy to discuss their programs with Connecticut SNAP recipients. Interested persons do not need to live in the town where the services are provided and may self-initiate at any location.
