The Commissioner of the Ct. Dept. of Housing will be visiting Gosinski Park and the Board of Directors along with our AIA, Housing Consultant, and Mayor on 9.9.2019;

- ➤ \$222,700 Life Safety Critical Needs CT. CHFA grant/loan. The \$5,100 Lightning Protection Equipment Change order has been approved by the State. Final Close out paperwork activities occurring.
- > \$278,000 Pre-Development Grant/loan documents signed by State Secretary. Awaiting additional disbursement from the state to bring up all AP payments up-to-date.
- \$53,509.56 LED Eversource project is 100% complete. Eversource's
  \$21,869.53 (approximate 41% match) has been received, deposited, and
  disbursed to PTE. In a separate contract from the Eversources award; the
  new exterior security Led Wall Packs have installed, minor adjustments
