Minutes

November 10, 2021

Beautification Committee Chairman Randy Olmstead called the November 10, 2021 Beautification Committee Meeting to order at 7:02 p.m. in the Senior Lounge at Plymouth Town Hall, 80 Main Street, Terryville, Connecticut.

Pledge of Allegiance

Beautification Committee Chairman Randy Olmstead led the Beautification Committee Members and the audience in the Pledge of Allegiance.

Acceptance of Minutes

A motion was made by Beautification Committee Member Jerry Milne, seconded by Beautification Committee Member Dave Perugini, to accept the October 13, 2021 minutes. This motion was approved unanimously.

New Business

a. Christmas decorations

Plymouth 225 Co-Chair Chalaine Kilduff received an anonymous donation in the amount of \$2500.00 to pay for the lights on the tree.

Beautification Committee Member Pamela Wilson stated that getting an outlet at Plymouth Green is hard. There is only 1 outlet at the Church.

A discussion took place about the electrical outlets and how a cord can run from the tree to the outlet.

The Committee will meet with Dave, the electrician on Sunday, November 14th at 3:30 PM to go over the details of getting power out there from the outlet.

A vote was done to see what color lights the tree should have.

Vote results:
Color lights – 4
White lights - 7

Beautification Committee Member Mary Semon talked about the tree she is donating that is going to be placed in the Gazebo at Baldwin Park.

The Committee will meet at the old fire house on November 27th at 10:00 AM to decorate the poles and put up the Christmas decorations. The Fire Department will be helping.

The planters will be covered at Veterans Memorial.

Beautification Committee Member Pamela Wilson will clean out the planters at Baldwin Park.

Beautification Committee Member Dave Perugini will research where to buy lights for the tree.

b. Christmas tree carol

Plymouth 225 Co-Chair Chalaine Kilduff talked to the music director at Fisher Elementary School. Fisher will be participating. Their choir will be singing 5 songs.

Pastor Denise and Tracy Fitzpatrick will have carolers from their Churches participate.

The Committee discussed having Santa and Mrs. Claus arrive on a fire truck.

The following food will be available for purchase:

Plymouth Congregational Church – chili

Baptist Church – corn bread

Terryville Congregational Church – hotdogs and hot cocoa

The event will take place on Friday, December 3rd from 6:00 PM – 8:00 PM with a rain date of Sunday, December 5th.

Plymouth Committee Co-Chair Chalaine Kilduff stated the Committee would pay for the horse drawn carriage from Wood Acres. Participants can make a donation.

c. Tree lighting

A motion was made by Beautification Committee Member Pamela Wilson, seconded by Beautification Committee Member Dave Perugini that if a tree is not donated, then the Beautification Committee would purchase a tree not to exceed \$200.00. This motion was approved unanimously.

d. Follow up on planters

Beautification Committee Members Dave Perugini and Jerry Milne are picking up the planters on Sunday at the green

Plymouth 225 Co-Chair Anita Hamzy would like to help on November 27th.


