2. Fire Exit Notifications:
Chairman Victor Mitchell noted the fire exits.

3. Pledge of Allegiance:
Chairman Victor Mitchell led the group in the Pledge of Allegiance.

4. Approval of Minutes dated July 28, 2021


Committee Member/Ed Benecchi reported that he has talked with her aid.
