A motion was made by Commissioner Victor Mitchell, seconded by Commissioner Daniel Wollenberg to accept the Fire Marshal's budget for 2022/2023 as presented with staffing of a Fire Marshal/Deputy Fire Marshal from \$61,975.68 to \$49,894.00. This motion was approved unanimously.
