#### **Minutes**

February 14, 2017

## Adoption of the Agenda

## **Public Comment on Agenda Items**

Ralph Zovich, 4 Knight Lane, Terryville, Chairman Board of Finance, stated he was present to support the appointment of James Kilduff, noting he would be an excellent addition to the Board of Finance. He further stated he wanted to address the issue of nepotism, noting Plymouth was a small community whereby many people were related to each other, however that doesn't stop the Board of Finance from thinking clearly, and the Board would focus on what was best for the citizens.
