Safety Committee Minutes September 17, 2020

**Call the meeting to order:** Chairman Charles Doback called the scheduled September 17, 2020, Safety Committee Meeting to order at 11:04 a.m. via ZOOM.

Chairman Doback called a moment of silence in honor of September 11th.

## Approval of minutes dated February 20, 2020:

### Training update:

Chairman Doback thanked Tony Orsini, Emergency Management Director for supplying PPE and hand sanitizer. He did a good job for the town.

Chairman Doback thanked Ann Marie Rheault for helping purchase supplies and Joe Kilduff for coordinating the opening at the front door at town hall.

Chairman Doback stated there is a records clerk in the police station as dispatch center has been outsourced.

Fire Department Station 1 is in the process of getting a new generator.

CIRMA is requiring injury forms be done online.

The annual sprinkler test was done at town and the ambulance building.

The Superintendent and Paul Hendrickson, the business manager left in September.
