Safety Committee Minutes

December 29, 2020

Call the meeting to order: Chairman Charles Doback called the scheduled December 29, 2020, Safety Committee virtual meeting to order at 11:04 a.m. via ZOOM.

Present were: Chairman Charles Doback, Raymond Kovaleski, Fire Marshal; Police Chief Karen Krasicky, Jason Patrick from WPCA; Charles Wiegert, Director of Public Works and James Mazon, Board of Education.

Approval of minutes dated September 17, 2020:

A motion was made by Police Chief Karen Krasicky, seconded by Charles Wiegert to approve the September 17, 2020 Minutes. This motion was approved unanimously.

Training update:

Chairman Doback reported that he received correspondence from CIRMA regarding training that has been completed 2019/2020 annal report.

There were 140 eLearning classes.

Library 11 employees took 31 classes

Police Department 22 employees took 103 classes

Town Hall 2 employees took 2 classes online which was required for sexual harassment.

2 police department employees on opioid training. 95 traditional class trainings, 2 snow plowing and 91 sexual harassment trainings.

In-person trainings will be scheduled in the future, when possible.

Jim Mazon stated the Board of Education employees all completed their sexual harassment training.

Chariman Doback will work with Mark Wantroba (H.D. Segur) to get classes set up for the Public Works department.

Old Business:

Chairman Doback stated that Public Works Director is working on fire drills and procedures at town hall. Gretchen Delcegno is making progress at the library.

New Business:

a. 2021 Meeting Dates

A motion was made by Police Chief Karen Krasicky, seconded by Jason Patrick to approve the 2021 meeting dates. This motion was approved unanimously. See attached memo.

Chairman Doback went over the CIRMA workers compensation year-end review. There were 17 claims over \$236,438.03 net incurred.

Fire Department - cuts and fracture

2 different employees getting contusions

Police Department - sprains, contusions, hearing loss, cuts, puncture, rotator cuff, sprains and strains. 9 claims some related to employees subduing suspects.

Public Works department - 3 claims - stepped in hole doing lawn maintenance, strain and contusion and cut and puncture in garage

Water Pollution – 1 strain to lower back

This report is to keep the supervisors to know what to do and come up with policies or training
