

CITY COUNCIL REORGANIZATION MEETING MINUTES
MONDAY, JULY 1, 2013 – 12:00 NOON
OC FREE PUBLIC LIBRARY

ATTENDANCE: Mr. DeVlieger, Mr. Guinosso, Mr. Hartzell, Mr. McClellan, Mr. Ping, Mr. Wilson and Mr. Allegretto. Also present: Mayor Gillian, Mr. Dattilo, Business Administrator and Ms. McCrosson, City Solicitor.

Linda MacIntyre, City Clerk called the meeting to order at 12:00 Noon and asked everyone to rise for the flag salute and prayer. She announced the meeting had been advertised in accordance with P.L. 1975, Chapter 231.

Mrs. MacIntyre announced that nominations were open for the office of City Council President for a one-year term beginning July 1, 2013 and terminating June 30, 2014. Mr. DeVlieger offered the motion to nominate Mr. Wilson; seconded by Mr. Hartzell. There were no other nominations. A unanimous aye vote followed.

Mrs. MacIntyre announced that nominations were open for the office of City Council Vice President for a one year term beginning July 1, 2013 and terminating June 30, 2014. Mr. McClellan offered the motion to nominate Mr. Allegretto; seconded by Mr. Hartzell. There were no other nominations. A unanimous aye vote followed.

The clerk then turned the meeting over to Mr. Wilson the elected President of City Council.
