CITY COUNCIL MEETING MINUTES THURSDAY, JANUARY 14, 2016 - 7:00 PM COUNCIL CHAMBERS

ATTENDANCE: Ms. Bergman; Mr. DeVlieger; Mr. Guinosso; Mr. Madden; Mr. McClellan, Mr. Wilson and Mr. Hartzell. Also present was Mayor Gillian, Mr. Mallon, Business Administrator and Ms. McCrosson, City Solicitor.

Council President Hartzell called the meeting to order at 7:00 pm and asked everyone to rise for the flag salute. He announced the meeting had been advertised in accordance with P.L. 1975, Chapter 231.

CITIZEN COMMENT

Ed O'Donnell, Port-O'Call – Thanked Council for the Soul Food dinner for the Martin Luther Celebration. He announced that he is running on the New Hampshire Presidential Election Ballot, 3rd Party. Would like to see a a 100 percent smoke free environment at the bus station.

APPROVAL MINUTES

Mr. Hartzell asked for a motion to adopt the Regular City Council Meeting minutes and Closed Executive Session meeting minutes of December 28, 2015. Motion moved by Mr. Wilson, seconded by Ms. Bergman. All ayes followed.

REPORTS – CITY COUNCIL

Mr. Mallon, Business Administration announced Mayor would be presenting a 5-year Capital Plan Presentation on Tuesday, January 19, 2016 and a Town Hall meeting on January 25, 2016 at 7:00 pm on dredging at the Library. Mayor Gillian will present the State of the City and distribute his proposed budget on February. 11, 2016. Mr. Mallon said Michael Baker International has completed the aerial survey work and onsite surveys are nearly complete and a project update with a recommendation to be made in mid-February.

Mr. Mallon introduced Ana Pereira, community manager of the American Cancer Society "Making Strides Against Breast Cancer" awareness program based in Cherry Hill. She presented a plaque to Ocean City for their continued support and active involvement that we have given them, and looking forward for the 10th year walk on the boardwalk.

REPORTS - CITY COUNCIL

Mr. Hartzell reminded residents about the Martin Luther King event this weekend at the High School and Hughes' Performing Art Center. A Soul Food Dinner will prepared by Shiloh Baptist Church, and a City wide cleanup event on Monday at the Community Center. Mr. Hartzell then thanked all the people who have embraced this event. Mr. McClellan announced the honorees of the event are Michael Dattilo and Marion Davis, former employees of the City for their years of service.

Mr. Hartzell then asked the Clerk to read Resolution #1 by title:

Mr. Hartzell explained how the interviews for the Zoning Board would be conducted. He then asked for a motion to adopt Resolution #1. Motion moved by Wilson seconded by Guinosso, all ayes followed.

Mr. Hartzell asked for a Motion to move into Closed Executive Session at 7:20 pm. Motion moved by Mr. Wilson seconded by Mr. DeVlieger, all ayes followed.

RETURN TO OPEN SESSION

Mr. Hartzell asked for a motion to return to Open Session at 8:36 pm. Motion moved by Mr. Wilson, seconded by Mr. Guinosso. All ayes followed.

Mr. Hartzell announced that while in closed session Council addressed candidates in a general manner but did not deliberate. Mr. Hartzell said he would go around the table and ask Council members an overview of the interviews.

Mr. Hartzell clarified to Council that nominations would be to keep an alternate in place or move them up to a regular member or to nominate an applicant that was interviewed. Mr. Hartzell asked for a nomination for the first vacant seat. Mr. Wilson nominated Mr. Waddell for the 1st vacant seat, seconded by Ms Bergman. Motion moved by Bergman, seconded by Mr. Madden. All ayes followed.

Mr. Hartzell asked for a nomination for the 2nd vacant seat. Mr. Guinosso nominated Mr. Quinn, there was no second motion. Motion failed to nominate Mr. Quinn.

Mr. DeVlieger nominated Mr. Buck, seconded by Mr. Madden. All ayes followed.

Mr. Hartzell asked for a nomination to fill the Alternate I position. Mr. McClellan nominated Mr. Rotondi, Mr. Wilson seconded the motion, all ayes followed.

Mr. Hartzell asked for a nomination for the Alternate II position. Ms. Bergman nominated Mr. Quinn, seconded by Mr. Guinosso. All ayes followed except Mr. DeVlieger and Mr. Madden voted no.

Mr. Harizell thanked everyone who participated and encouraged them to reapply next year.

Mr. Hartzell asked the Clerk to read Resolution #2.

<u>16-52-002 - #2.</u> A Resolution Adopting the 2016 Budget of the Special Improvement District of the City of Ocean City - *Public Hearing on Resolution #2.* Mr. Donato explained the SID Budget of \$513,448 includes a \$183,448 levy on commercial properties within the district. The budget was introduced at the December 17 meeting and requires a second reading and public hearing. Mr. Donato said he asked representatives from 9th Street District, Boardwalk Merchants and Downtown Merchants Association to provide a memo summarizing how the funds are used because of the time restriction due to the Closed Executive Session.

PUBLIC COMMENT - Resolution #2. There was no public comment.

Mr. Hartzell asked for a motion to adopt Resolution #2. Mr. McClellan, made a motion seconded by Ms. Bergman. All ayes followed.

ORDINANCES: SECOND READING & PUBLIC HEARING

Mr. Hartzell asked for a motion to take up Ordinance #15-30 on second reading. Motion moved by Mr. Wilson, seconded by Mr. McClellan. All ayes followed. The clerk read the ordinance by title: #15-30: An Ordinance Amending Chapter V (General Licensing) and Chapter XXX (Municipal Fees) of the Revised General Ordinances of the City of Ocean City, New Jersey Regarding Peddlers, Hawkers and Vendors. Ms. McCrosson offered an explanation stating that the city purchasing agent suggested reducing the number of bicycle carts to 10 and vendors can sell their ice cream from 10 am to 6 pm and must be approved by the County Department of Health.

PUBLIC COMMENT – There was no public comment.

Mr. Hartzell asked for a motion to adopt Ordinance #15-30 on second reading. Motion moved by Mr. Wilson, seconded by Mr. Guinosso. All ayes followed.
