CITY COUNCIL MEETING MINUTES TUESDAY, OCTOBER 11, 2016 – 7:00 PM CITY HALL COUNCIL CHAMBERS

ATTENDANCE: Mr. Barr, Ms. Bergman, Mr. DeVlieger, Mr. Hartzell, Mr. McClellan, Mr. Wilson and Mr. Madden. Present also was Mayor Jay Gillian, Administrator, James Mallon and Elizabeth Woods, Esq.

Council President Peter Madden called the meeting to order and asked everyone to rise for the flag salute and prayer.

CITIZEN COMMENT:

<u>Brenda Braun – 326 West Avenue</u> – Ms. Braun is the newly elected President of the Ocean City Community Association; she spoke to council about the association's mission statement, goals for 2017 as far as community events and also about getting involved with other existing organizations in the city.

<u>Jesse Schmeizer – 318 East Surf Road</u> – Mr. Schmeizer is an Ocean City High School student who runs on the cross country track team; he informed council and administration that public works vehicles are driving on the new turf field and he is concerned about the wear and tear.

APPROVAL OF MINUTES:

Mr. Madden asked for a motion to approve the Regular City Council Meeting Minutes of Thursday, September 22, 2016. Motion moved by Mr. Wilson, seconded by Mr. Hartzell. All ayes followed.

REPORTS – MAYOR & ADMINISTRATION:

First, Mr. Mallon welcomed and thanked Liz Woods who joined council and the administration tonight as she filled in for Ms. McCrosson. Mr. Mallon read a proclamation in recognition of Fire Prevention Week which is from October 9th through October 15th in Ocean City. Mr. Mallon reported that last week several members of the city team along with ACT Engineers visited Poplar Island in the Chesapeake, an island after nearly eroding away, has been built back to nearly 1,100 acres with dredge spoils and sand. The project is being managed by the Baltimore Army Corps of Engineers and the Maryland Environmental Service. The dredge material is coming from channels that lead to the Baltimore Harbor. This is a great example of what can be done when all agencies work together. Next, Mr. Mallon informed everyone that work started today on the next phase of the boardwalk reconstruction project which is from 8th Street to 10th Street. Also, the re-decking of the 34th Street Bridge is scheduled to begin with a tentative date of October 20th and there will be lane closures and delays. The West 17th Street Bridge project will most likely start in November. The city will receive silver certification in the Sustainable Jersey program in November. At this time, silver is the highest level the city can achieve. A lot of hard work was put in by the Green Team, including Mary Mozzo, Matt von der Hayden, Doug Bergman and several others. The city also received the Municipal Blue Star Certification today from Clean Ocean Action for environmental work done including the BioSale. Ocean City is the first municipality in Cape May County to receive this certification and one of only 6 municipalities in the State of New Jersey. Also, the last day to register to vote is October 18th and the City Clerk's office will be open until 8:00 p.m. Lastly, CFO, Frank Donato will be providing some brief updates to share with everyone along with some additional good news for the city.

CFO, Frank Donato provided an explanation on resolution numbers 17 and 18. Mr. Donato let everyone know the city has been awarded a grant in the amount of \$403,889.00 from the Department of Community Affairs to cover the city's FEMA cost share; Mr. Donato and Matt von der Hayden worked together on obtaining this grant for the city.

Mr. Hartzell thanked Mr. Schmeizer for speaking to council about his concerns relative to the new turf field. Mr. Hartzell acknowledged him for his maturity level, his approach and he also said that Mr. Schmeizer carries himself very well and he sets a great example.

Ms. Bergman wanted to know how the city did this summer financially relative to beach tag sales and parking fees. Also, she let Ms. Braun, President of the Ocean City Community Association, know that she would like to attend their meetings and be involved to help the association any way that she can.

Mr. Wilson thanked Mr. Donato and Mr. Von der Hayden for all of their efforts and hard work obtaining the grant money for the city. Also, Mr. Wilson wanted to know what can be done about the foxes in the city.
