### CITY COUNCIL MEETING MINUTES TUESDAY, OCTOBER 25, 2016 – 7:00 PM CITY HALL COUNCIL CHAMBERS

ATTENDANCE: Mr. Barr, Ms. Bergman, Mr. DeVlieger, Mr. Hartzell, Mr. McClellan, Mr. Wilson and Mr. Madden. Present also was Mayor Jay Gillian and Business Administrator, James Mallon.

Council President Peter Madden called the meeting to order and asked everyone to rise for the flag salute and prayer.

### **CITIZEN COMMENT:**

There wasn't anyone from the public who wished to speak to council.

### **APPROVAL OF MINUTES:**

Mr. Madden asked for a motion to approve the Regular City Council Meeting Minutes of Tuesday, October 11, 2016. Motion moved by Mr. Barr, seconded by Mr. Wilson. All ayes followed.

# REPORTS - MAYOR & ADMINISTRATION:

Business Administrator, James Mallon reported that the city has been notified that the Comcast local office in Ocean City will be closing as of November 18, 2016. This closing has been discussed for a couple of years and the city has done what they could within the laws to keep their office in town. Also, the city is having positive dialogue with the County regarding holiday decorations for the 34<sup>th</sup> Street area; the city should have final approval on locations and options from the County soon. The poles for Asbury Avenue will be going up shortly after Halloween with the decorations going up mid month. Mr. Mallon asks everyone to be cautious driving on the avenue while the decorations are put in place.

### **REPORTS – CITY COUNCIL:**

Mr. DeVlieger suggested that a committee be put in place to discuss the replacement of the Comcast building; the Utility Advisory Committee can go over what options are available and discuss alternative vendors.

# ORDINANCES – FIRST READING & INTRODUCTION:

Mr. Madden asked for a motion to take up Ordinance No. 16-28 on first reading and introduction. Motion moved by Mr. Wilson, seconded by Ms. Bergman. All ayes followed. The clerk read the ordinance by title. Ordinance No. 16-28 - An Ordinance Amending and Supplementing the Revised General Ordinances of the City of Ocean City, Chapter XII "Building and Housing" at Section 12-5 "Property Maintenance Code"

Mr. Mallon explained that this ordinance would make the provisions of the International Property Maintenance Code in effect in Ocean City applicable to historic properties. Currently, Code Enforcement can only compel correction of maintenance code violations affecting historic properties if the cost of correcting the violation equals more than 25% of the cost of replacing the entire improvement on which the violation occurs. This proposed ordinance would authorize the city's Code Enforcement officers to require maintenance of historic properties in the same manner and to the same extent as non-historic properties.

There was some discussion between the governing body and administration.

Mr. Madden asked for a motion to adopt Ordinance No. 16-28 on first reading and introduction and publish according to law. Motion moved by Mr. Wilson, seconded by Mr. Hartzell. All ayes followed with the exception of Mr. DeVlieger who recused himself. Mr. Madden announced that second reading and public hearing on Ordinance No. 16-28 will be held on November 10, 2016.
