CITY COUNCIL MEETING MINUTES THURSDAY, SEPTEMBER 14, 2017 – 7:00 PM CITY HALL COUNCIL CHAMBERS

ATTENDANCE: Ms. Bergman, Mr. DeVlieger, Mr. Hartzell, Mr. McClellan, Mr. Wilson and Mr. Madden. Present also was Business Administrator, James Mallon and Solicitor, Dorothy McCrosson. Mr. Barr was absent.

Council President Peter Madden called the meeting to order and asked everyone to rise for the flag salute and prayer. Ms. Bergman led the prayer. Mr. Madden announced that adequate notice of this meeting has been given pursuant to Public Law 1975, Chapter 231.

CITIZEN COMMENT:

<u>Michael Hinchman - 281 W. Atlantic Blvd</u> - Mr. Hinchman requested that the governing body table Resolution No. 14 and suggested a capital expenditures committee.

<u>Bob DelBane – 127 Haven Avenue</u> – Mr. DelBane spoke about a paving issue on his street and he submitted a petition that was signed to have the street be included in the next paving project.

APPROVAL OF MINUTES:

Mr. Madden asked for a motion to approve the Regular City Council Meeting Minutes of Tuesday, August 22, 2017. Motion moved by Ms. Bergman, seconded by Mr. Wilson. All ayes followed with the exception of Mr. Madden who abstained.

REPORTS - MAYOR & ADMINISTRATION:

Business Administrator, James Mallon reported that the city has had several great events this week, from a meeting on house raising grants, to a blood drive, to a great September 11th event. The city's team is doing a good job and they need to be commended. Mr. Mallon reminded everyone that the city had to go back out to bid on mechanical dredging for South and Sunny Harbors. Unfortunately, Pleasantville was not yet able to get approval to accept the city's material, but that does not mean that in the future this partnership will not be beneficial to both municipalities. This is an important example of why the city pursues multiple paths for dredge options. Also, Mr. Mallon reported that sewer repair on Bay Ave at 25th Street is expected to finish Friday. The Airport festival and airshow this weekend and a skydiving team will do a pyrotechnic jump Saturday night at 8:00 p.m. over the boardwalk landing on the beach between 7th and 8th. On Sunday night at the final POPS concert of the year, Miss NJ Kaitlyn Schoeffel, third runner up in Miss America will be greeting fans before the concert and during intermission. Also, Mr. Mallon addressed the comments made during public comment.

REPORTS - CITY COUNCIL:

Mr. McClellan discussed the public bidding process related to the purchase of the fire truck.

Mr. Hartzell said that it is more valuable to communicate and discuss the facts when there are questions and concerns.

Mr. DeVlieger attending a FIT meeting last week; there was a lot of discussion about the importance fixing infrastructure in an effort to be better prepared for storm related issues. Also, it is imperative that the city applies for grants relative to FEMA.

Mr. Wilson commented on the maintenance and management related to the ladder truck for the fire company.

ORDINANCES: FIRST READING AND INTRODUCTION:

Mr. Madden asked for a motion to take up Ordinance No. 17-17 on first reading and introduction. Motion moved by Mr. Wilson, seconded by Mr. McClellan. All ayes followed. The clerk read the ordinance by title. Ordinance No. 17-17 – An Ordinance Amending Ordinance #87-17, Chapter XXX "Municipal Fees" of the Revised General Ordinances of the City of Ocean City, New Jersey (Fee For Permit To Dredge Private Areas)

Solicitor, Ms. McCrosson explained that this ordinance allows for contractor's to pay an application fee for a municipal permit to dredge privately-owned areas under the authority of Ocean City's individual permit.

There was some discussion between the governing body.

Mr. Madden asked for a motion to adopt Ordinance No. 17-17 on first reading and introduction. Motion moved by Mr. Wilson, seconded by Ms. Bergman. All ayes followed. Mr. Madden announced that second reading and public hearing is scheduled for Thursday, September 28, 2017 and will be published according to law.

ORDINANCES: SECOND READING & PUBLIC HEARING:

Mr. Madden asked for a motion to take up Ordinance No. 17-15 on second reading and public hearing. Motion moved by Mr. Wilson, seconded by Ms. Bergman. All ayes followed. The clerk read the ordinance by title. Ordinance No. 17-15 – An Ordinance Authorizing the City of Ocean City to Convey Its Interest in the Land Known as Block 611.11, Lots 122 and 131 to Nicholas Talotta, Sr. (50% Owner) and the Family

Trust Created by the Veronica P. Talotta Revocable Trust Agreement Dated November 13, 2008 (50% Owner) in Exchange for a Deed of Dedication and Perpetual Storm Damage Reduction Easement

Solicitor, Ms. McCrosson explained Exhibit B and provided an explanation on the deed exchange.

There was some discussion between the governing body.

Mr. Madden opened up the meeting for public comment on Ordinance No. 17-15. There was not anyone from the public who wished to speak. Mr. Madden closed the public comment portion of the meeting.

Mr. Madden asked for a motion to adopt Ordinance No. 17-15 on second reading. Motion moved by Mr. Wilson, seconded by Ms. Bergman. All ayes followed.

Mr. Madden asked for a motion to take up Ordinance No. 17-16 on second reading and public hearing. Motion moved by Mr. Wilson, seconded by Mr. McClellan. All ayes followed. The clerk read the ordinance by title. Ordinance No. 17-16 – An Ordinance Revising Chapter XXI, Flood Damage Prevention of the Revised General Ordinances of the City of Ocean City, New Jersey (2017 Update)

Solicitor, Ms. McCrosson explained that this ordinance is an ordinance updating the City's Flood Damage Prevention ordinance to ensure that it meets FEMA's Map Modernization Program requirements, thus ensuring that Ocean City remains in good standing with the National Flood Insurance Program and that federally-backed flood insurance remains available to property owners in the city. This ordinance updates FIS and FIRM panel numbers, updates the map effective date and introduces a new "Coastal A Zone".

There was some discussion between the governing body.

Mr. Madden opened up the meeting for public comment on Ordinance No. 17-16. There was not anyone from the public who wished to speak. Mr. Madden closed the public comment portion of the meeting.

Mr. Madden asked for a motion to adopt Ordinance No. 17-16 on second reading. Motion moved by Ms. Bergman, seconded by Mr. Wilson. All ayes followed.
