CITY COUNCIL MEETING MINUTES THURSDAY, NOVEMBER 16, 2017 – 7:00 PM CITY HALL COUNCIL CHAMBERS

ATTENDANCE: Mr. Barr, Ms. Bergman, Mr. DeVlieger, Mr. Hartzell, Mr. McClellan, and Mr. Madden. Present also was Mayor Jay A. Gillian, Solicitor, Business Administrator, James Mallon and Solicitor, Dorothy McCrosson. Mr. Wilson was absent.

Council President Mr. Madden called the meeting to order and asked everyone to rise for the flag salute and prayer. Ms. Bergman led the prayer. Mr. Madden announced that adequate notice of this meeting has been given pursuant to Public Law 1975, Chapter 231.

CITIZEN COMMENT:

<u>Drew Fasey</u> – Mr. Fasey spoke about the importance of open space and said that he is in favor of Ordinance No. 17-19.

<u>Paul Chiolo – 1 Atlantic Avenue</u> – Mr. Chiolo informed council that the planning board gave its approval for the Keller Williams building on 9th Street. He showed council an enlarged photo of the proposed building and explained that it was a two year process to complete the plan and get all of the necessary approvals. All of the financing is in place and the building would consist of 22% coverage.

<u>Wayne Mozzo – 1333 Pleasure Avenue</u> – Mr. Mozzo spoke about his concerns regarding the check valves on 14th Street. He had questions about the purchase of the check valves; he wanted to know what the preventive measures will be and he wanted to know when the new check valves will be installed.

<u>David Breeden – 114 Victoria Lane</u> – Mr. Breeden asked about the fire alarm system for the 6th Street bathrooms. He also spoke about having the funding in place for various city projects and asked specifically about the salt storage facility. He wanted to know the status and the budgeted amount for that structure.

REPORTS – MAYOR & ADMINISTRATION:

Business Administrator, James Mallon informed everyone about some up-coming events. Earlier than the Bird is on Saturday morning, November 18th; the city's annual Christmas tree lighting is next Friday, November 24th; and horse and carriage rides are being held both weekends. Mr. Mallon reminded everyone to check the Ocean City app for all the latest updates. Also, Mr. Mallon thanked everyone who attended and participated on Veteran's Day, especially Mr. and Mrs. Strange the guest speakers and he wished everyone a Happy Thanksgiving.

REPORTS – CITY COUNCIL:

Mr. DeVlieger informed everyone about the Homeless Youth fundraiser event being held at DiOrio's in Somers point on Saturday, November 18th at 6:00 p.m.

Ms. Bergman provided an update on the Tourism Commission and informed everyone about the workshop being held December 5th which will be a public meeting to discuss the Tourism budget for 2018.

ORDINANCES: FIRST READING & INTRODUCTION:

Mr. Madden asked for a motion to take up Ordinance No. 17-21 on first reading and introduction. Motion moved by Ms. Bergman, seconded by Mr. Barr. All ayes followed. The clerk read the ordinance. Ordinance No. 17-21 – An Ordinance Establishing and Fixing a Range and Maximum Salary for Department Heads

Business Administrator, James Mallon explained that this ordinance sets a salary range for department heads to allow for consistency and fairness when the administration is pursuing promotions and hiring team members.

There was some discussion between the governing body.

Mr. Madden asked for a motion to adopt Ordinance No. 17-21 on first reading and introduction. Motion moved by Mr. McClellan, seconded by Ms. Bergman. All ayes followed. Mr. Madden announced that second reading and public hearing will be held on November 30, 2017 and will be published according to law.

ORDINANCES: SECOND READING & PUBLIC HEARING:

Mr. Madden asked for a motion to take up Ordinance No. 17-19 on second reading and public hearing. Motion moved by Mr. McClellan, seconded by Mr. DeVlieger. All ayes followed with the exception of Mr. Hartzell who recused himself. The clerk read the ordinance by title. Ordinance No. #17-19 — A Bond Ordinance Providing For Appropriating \$650,000 and Authorizing the Issuance of \$617,500 Bonds or Notes of the City to Finance Part of the Cost of the Acquisition By Negotiation or Condemnation of the Property Known as 903 Bay Avenue (Block 908-Lot 14)

Ms. McCrosson explained that there is a hearing scheduled for December 4, 2017 and the determination will be made as to whether or not the city is entitled to pay the money into the court regarding the filing the declaration of taking. After the taking is on the record and money is in court, the city will then become owners of the property known as 903 Bay Avenue (Block 908-Lot 14).

There was discussion between the governing body.

Mr. Madden opened the meeting up for public comment on Ordinance No. 17-19.

<u>Jim Tweed – 1512 Wesley Avenue</u> – Mr. Tweed expressed his thoughts on eminent domain and he stated that he was in support of Ordinance No. 17-19.

Mr. Madden closed the public comment portion of the meeting.

Mr. Madden asked for a motion to adopt Ordinance No. 17-19 on second reading and public hearing. Motion moved by Mr. McClellan, seconded by Ms. Bergman. All ayes followed.

Mr. Madden asked for a motion to take up Ordinance No. 17-20 on second reading and public hearing. Motion moved by Ms. Bergman, seconded by Mr. McClellan. All ayes followed. The clerk read the ordinance by title. Ordinance No. 17-20 - An Ordinance to Grant an Assignment of Easement by the City of Ocean City, Cape May County, New Jersey to the State of New Jersey, Department of Environmental Protection for the Purpose of Providing Access for the United States Army Corps of Engineers to Construct the Great Egg Harbor Inlet and Pecks Beach, New Jersey Project on Block 70.41, Lots 2 & 3 in the City of Ocean City

Business Administrator, James Mallon explained that this ordinance is asking council to approve the assignment of rights to the easement from the City alone, to the State and the city in order to enable the city and Army Corps of Engineers, the city's partners in beach projects, to construct and maintain the beach. This assignment will help maintain regular beach projects in the future.

There was discussion between the governing body.

Mr. Madden opened the meeting up for public comment on Ordinance No. 17-20. There was no public comment. Mr. Madden closed the public comment portion of the meeting.
