# CITY COUNCIL MEETING MINUTES THURSDAY, JANUARY 11, 2018 – 7:00 PM CITY HALL COUNCIL CHAMBERS

ATTENDANCE: Mr. Barr, Ms. Bergman, Mr. DeVlieger (7:05 p.m.), Mr. Hartzell, Mr. McClellan, Mr. Wilson and Mr. Madden. Present also was Mayor Jay A. Gillian, Business Administrator, James Mallon and Solicitor, Dorothy McCrosson.

Council President Mr. Madden called the meeting to order and asked everyone to rise for the flag salute and prayer. Ms. Bergman led the prayer. Mr. Madden announced that adequate notice of this meeting has been given pursuant to Public Law 1975, Chapter 231.

#### CITIZEN COMMENT:

Robert Miller - 57 Central Road - Mr. Miller expressed his concerns about voting issues and the right for public speaking.

<u>Carolyn Logan – 149 Bark Drive</u> – Ms. Logan submitted photos of 52<sup>nd</sup> Street brush that has been removed. She is very concerned about the removal of the brush and requests that the city replace 42 shrubs within the next six months.

<u>Jack McGonigle – 160 Anchorage Drive</u> – Mr. McGonigle expressed his concerns about the brush removal at 52<sup>nd</sup> Street and requested that trees get replanted.

<u>Donna Moore – 21 Ocean Ave</u> – Ms. Moore spoke about the importance of root structures of well-established plants and she spoke about her concerns and suggestions for the brush at 52<sup>nd</sup> Street. She had a poster that she made and also demonstrated with paper taped together what 42 trees looks like.

<u>Marie Haves – 641 Battersea Road</u> – Ms. Hayes congratulated the Eagle Scout's for their achievements. She also spoke about her concerns about the brush removal at 52<sup>nd</sup> Street and wants to see the city replace the trees and shrubs. Ms. Hayes had questions and concerns relative to Ordinance No. 17-23 on the agenda.

Mr. Madden opened the meeting up for public comment on Resolution No.'s 1 and 2. There was no one from the public who wished to speak. Mr. Madden closed the public comment portion of the meeting.

Mr. Madden asked for a motion to approve Resolutions 1 and 2. Motion moved by Mr. Barr, seconded by Mr. Wilson. All ayes followed.

# APPROVAL OF MINUTES:

Mr. Madden asked for a motion to approve the regular city council meeting minutes of Thursday, December 28, 2017. Motion moved by Ms. Bergman, seconded by Mr. Wilson. All ayes followed with the exception of Mr. Hartzell who abstained.

#### **REPORTS - MAYOR & ADMINISTRATION:**

Business Administrator, Mr. Mallon addressed some recent concerns regarding maintenance work on 52<sup>nd</sup> Street. The city owned strip of land along the shoulder of 52<sup>nd</sup> Street had routine maintenance in and around a city owned split rail fence. The primary objective of the brush removal was to provide improved and clearer access to the historically grassy area. The path near the split rail fence is an area commonly used by neighborhood pet owners to walk their animals and nearby homeowners appreciate the city keeping the area maintained. Mr. Mallon reported that over the last couple of years the brush, primarily compromised of phragmities had grown so excessively that the plant was forcing its way through the split rail fence making it very difficult for team members to maintain the area. In addition, the density of the brush seemed to foster the rapid growth of several varieties of unwelcome growth, such as poison ivy and sumac. The vegetation that was removed provides no protection from tidal flood waters and in actuality, the spread of phragmities threatens other plant and animal species. Mr. Mallon stated that the city recognizes the value of native trees and shrubs and team members have been instructed to be more precise in instructions for future projects and will be asking

contractors to contact a project manager if they are unclear on direction. On another note, the administration would like to recognize and congratulate Sea Isle City's recent achievement of moving to CRS level 3. This is a great achievement. The city team plans on bringing several documents before city council over the next few meetings in order to put Ocean City in a position to receive the same certification. The city is at level 5 now and is optimistic that they can reach level 3 soon. Mr. Mallon said it is great to see neighboring communities working toward similar goals. Additionally, NJ American Water and South Jersey Gas will begin work on an infrastructure improvement project on Roosevelt Blvd. Depending on the weather, this project could start in a couple of weeks. The project will start on the eastern end of Roosevelt Blvd approaching Bay Ave and will proceed to the beach and along Central Avenue. Residents will be notified and the city will post project maps on the city website. Lastly, Mr. Mallon reminded everyone about the Martin Luther King, Jr. celebration being held Saturday, January 13, 2018 at 1:00 p.m. at the high school.

Ordinance No. 17-23 - An Ordinance Amending and Supplementing Chapter XXV, Zoning and Land Development of the Revised General Ordinances of the City of Ocean City, Cape May County, State of New Jersey (Hedges; Curbside Plantings)

Solicitor, Ms. McCrosson explained that this ordinance would allow for removing the height limit on hedges.

There was discussion between the governing body.

Mr. Madden asked for a motion to adopt Ordinance No. 17-23 on first reading and introduction. Motion made by Mr. Wilson, seconded by Ms. Bergman. All ayes followed. Mr. Madden announced that second reading and public hearing is scheduled for Thursday, January 25, 2018 and will be published according to law.
