CITY COUNCIL MEETING MINUTES THURSDAY, FEBRUARY 28, 2019 – 6:00 PM CITY HALL COUNCIL CHAMBERS

ATTENDANCE: Mr. Barr, Ms. Bergman, Mr. DeVlieger, Mr. Hartzell, Mr. McClellan, Mr. Wilson and Mr. Madden. Present also was Mayor Gillian, Business Administrator, Mr. Savastano and Solicitor, Ms. McCrosson.

Council President Mr. Madden called the meeting to order and asked everyone to rise for the flag salute and prayer. Mr. Madden announced that adequate notice of this meeting has been given pursuant to Public Law 1975, Chapter 231.

Mr. Madden asked for a motion to amend the consent agenda to add a resolution Appointing Albert Cortese to the Zoning Board of Adjustment as an Alternate II Member. Motion made by Mr. Hartzell, seconded by Mr. Barr. All ayes followed.

CITIZEN COMMENT:

<u>Donna Moore – 21 Ocean Ave</u> – presented council with a handout and spoke about healthier living as well as her concerns about pesticides being used.

<u>Dave Breeden – 114 Victoria Lane</u> – thanked the city for tearing down the building at 36th and Bay. Expressed comments and concerns regarding Resolution No. 17 on the agenda.

Mr. Madden asked for a motion to approve the regular city council meeting minutes of Thursday, January 24, 2019 and the closed executive session minutes of Thursday, January 24, 2019. Motion moved by Mr. Barr, seconded by Mr. Wilson. All ayes followed.

The 2019 State of the City Address was given by Mayor Jay A. Gillian.

The Capital Plan Presentation was given by CFO, Frank Donato and Aide to the Mayor, Vince Beiker.

ORDINANCES: FIRST READING & INTRODUCTION:

Mr. Madden asked for a motion to take up Ordinance No. 19-02 on first reading and introduction. Motion moved by Ms. Bergman, seconded by Mr. Hartzell. All ayes followed. The clerk read the ordinance by title. Ordinance No. 19-02 – An Ordinance Supplementing the Revised General Ordinances of the City of Ocean City (Boardwalk Entertainers)

Solicitor, Ms. McCrosson explained that this ordinance prohibits electric amplified devices for performances.

Mr. Madden asked for a motion to adopt Ordinance No. 19-02 on first reading and introduction. Motion moved by Mr. Hartzell, seconded by Mr. McClellan. All ayes followed. Mr. Madden announced that second reading and public hearing is scheduled for Thursday, March 14, 2019 and will be published according to law.

Mr. Madden asked for a motion to take up Ordinance No. 19-03 on first reading and introduction. Motion moved by Mr. Barr, seconded by Mr. McClellan. All ayes followed. The clerk read the ordinance by title. Ordinance No. 19-03 - An Ordinance Amending, Revising and Supplementing Chapter XXV, Zoning and Land Development Ordinance of the Revised Ordinances of the City of Ocean City to Provide for a Minimum Set Aside of Affordable Housing Units to Meet the City of Ocean City's Affordable Housing Obligation and Repealing All Ordinances Heretofore Adopted the Provisions of which are Inconsistent Therewith

Solicitor, Ms. McCrosson explained that this ordinance sets forth regulations regarding the percentage of housing units devoted to low and moderate income households required within an inclusionary development in Ocean City that are consistent with the court-ordered agreement.

There was some discussion between the governing body.

Mr. Madden asked for a motion to adopt Ordinance No. 19-03 on first reading and introduction. Motion moved by Mr. Barr, seconded by Ms. Bergman. All ayes followed. Mr. Madden announced that second reading and public hearing is scheduled for Thursday, March 28, 2019 and will be published according to law.

Mr. Madden asked for a motion to take up Ordinance No. 19-04 on first reading and introduction. Motion moved by Mr. Wilson, seconded by Mr. Barr. All ayes followed. The clerk read the ordinance by title. Ordinance No. 19-04 – An Ordinance Amending and Supplementing Chapter XXV, Zoning and Land Development of the Revised Ordinances of the City of Ocean City – <u>Inclusionary R-2 Zone Districts Assemblage Incentive Overlay Zone</u>

Solicitor, Ms. McCrosson explained that this ordinance is intended to adopt an inclusionary overlay zone applicable to all R-2 zone districts, triggered by an assemblage of at least 25% of the land area of a block that is designated R-2 zone district.

There was some discussion between the governing body.

Mr. Madden asked for a motion to adopt Ordinance No. 19-04 on first reading and introduction. Motion moved by Mr. Hartzell, seconded by Mr. Wilson. All ayes followed. Mr. Madden announced that second reading and public hearing is scheduled for Thursday, March 28, 2019 and will be published according to law.

Mr. Madden asked for a motion to take up Ordinance No. 19-01 on second reading and public hearing. Motion moved by Mr. DeVlieger, seconded by Ms. Bergman. All ayes followed. The clerk read the ordinance by title. Ordinance No. 19-01 - An Ordinance Amending Chapter XXV, Ocean City Zoning and Land Development Ordinances of the City of Ocean City, Section 25-203.5, "Prohibited Uses and Structures in All Zones"

Solicitor, Ms. McCrosson explained that this ordinance will prohibit businesses which cultivate, manufacture, test or sell marijuana and marijuana paraphernalia.
