PENDING BUSINESS:

Mr. Barr spoke about re-opening the city slowly, carefully and methodically. The health of the people is important and the city will act in accordance with the other shore towns. Guidance will be given from the Governor on Monday.

Mr. Hartzell spoke about the importance of having extra supplies if something like this should happen in the future. He spoke about Resolution No. 18 and thanked the administration for their efforts. Also, Mr. Hartzell talked about restaurants opening back up for business and suggested that they have the consent to increase their sidewalk seating temporarily. Another suggestion that Mr. Hartzell brought up had to do with retail stores; if the boardwalk remains closed then maybe it would be possible for patrons to use the rear entrances to the retail stores. Mayor Gillian commented that the city will re-open the right way and will not put people's health at risk.

Ms. Bergman said that she would like to commend the administration for all of their efforts during this pandemic; the communication between the Mayor, business community, city council and Shore Medical is greatly appreciated. Ms. Bergman encouraged everyone to support the local businesses by ordering take-out and participating in virtual sales online which allows you to shop.

Mr. Wilson said that although we are living in crazy times we are still very blessed. Everyone is working together and bouncing ideas off of each other during this challenging time, but we do have great resources.

NEW BUSINESS:

No new business was discussed.

CITIZEN COMMENT:

<u>Donna Moore – 21 Ocean Ave</u> – said thank you for holding the meeting and she thanked the Mayor for his cautious approach. She also commented that she found the promotional commercial on you tube to be confusing. Ms. Moore talked about organic land management and she asked the city to consider using organic products on the youth athletic fields. Ms. Moore thanked Ms. McCrosson for providing information about the contract with Verizon. Lastly, she asked about the end fill material for the artificial turf at the airport. She wanted to know if it will be strictly sand.

<u>Chuck Deal – 2837 Central Ave</u> – said he appreciates the council having the meeting and he spoke about Ordinance No. 19-22. He expressed his concerns and said that the 30% increase in impervious coverage could be a problem.
