Council President Mr. Barr called the meeting to order and asked everyone to rise for the flag salute and prayer. Mr. Barr asked for a moment of silence in remembrance of Frank McCall who recently passed away. Mr. Hartzell then led the prayer. Mr. Barr announced that adequate notice of this meeting has been given pursuant to Public Law 1975, Chapter 231.

REPORTS - MAYOR & ADMINISTRATION:

No reports were given.

CITIZEN COMMENT:

<u>Jean Rynkiewicz – 1402 West Ave</u> – spoke about her concerns about flooding in her neighborhood.

BOND SALE ANNOUNCEMENT:

The City Clerk read the following aloud: The Chief Financial Officer of the City of Ocean City, in the County of Cape May, New Jersey certifies that he has awarded general obligation bonds to be dated October 15, 2020, in the amount of \$50,700,000. Ocean City received 22 bids from 7 different banks and financial institutions through a competitive online process. The bonds will be awarded to bank of America Securities for \$50,700,000 at a Net Interest Cost of 1.52%. A complete report of all bids is available through the City Clerk's office.

Also, he is just as concerned as the other residents on and around 14th Street and hopes to have a plan in place soon to alleviate the flooding issues. Also, Mr. Hartzell said he received a letter from Beverly Gill suggested that when people are in/on the water they may not know where they are and proposed that markers be placed on every bulkhead.

Ms. Bergman spoke about Beverly and Frank McCall and gave her condolences to their family. She also thanked all of the candidates who have applied for the Boards and Commissions; the quality if the candidates for the Environmental Commission was outstanding.

Mr. DeVlieger gave his sincere condolences to Frank McCall and his family. Mr. DeVlieger also said that he is very impressed with the talent that has been coming out for the Boards and Commissions.

CITIZEN COMMENT:

<u>Karen Dardine – 110 West 17th Street</u> – expressed her concerns about the flooding that occurs near her home. She said it is becoming dangerous and more consistent; the flooding is coming up to knee length and she has submitted pictures for administration and city council to see.

<u>Dave Breeden – 114 Victoria Lane</u> – spoke about a meeting that took place regarding plans for a public safety building; Mr. Breeden met with the Mayor, Administrator, Chief of Police and CFO and said that the meeting went well and he appreciated the time that everyone took to discuss the proposed plans and finances.

Nelson Dice – 12th and Central – made comments about the different constitutions for the nation and also recited a part of the Declaration of Independence.

<u>Bill Rynkiewicz – 1402 West Ave</u> – spoke about a vacant property located at 210 E. 14th Street; the foundation is falling apart and the roof has a hole in it. He asked about the status of the home and what is being done as it is a safety hazard.

<u>Bill Hartranft – 728 Battersea Road</u> – said that he is gratified by Mr. Levchuk's comments and said that he supports Ms. Moore's efforts.

<u>Donna Moore – 21 Ocean Ave</u> – thanked everyone for their support regarding limiting the use of pesticides on public land and also thanked city council for conducting the phone interview for the Environmental Commission; she respectfully declined being a candidate because she likes being able to speak on environmental issues independently.

Warren Dardine - 110 West 17th Street – raised concerns about a sewer plant being put somewhere in the middle of where he lives.
