# AUTHORIZING PAYMENT TO THE OCEAN CITY REGIONAL CHAMBER OF COMMERCE FOR THE OPERATION OF THE WELCOME CENTERS

This resolution is to partner with the Ocean City Chamber of Commerce for the operations and handling of phone calls to the 800-BEACHNJ phone line and associated fulfillment at the 34<sup>th</sup> Street Welcome Center and the Welcome Center on the Route 52 Causeway.

#### AUTHORIZING AN OUTDOOR MEDIA BUY

This resolution authorizes the lease of two (2) billboards on I-95 from CBS Outdoor to promote Ocean City. Each of these two billboards are available for 4 weeks beginning July 1, 2013 to July 31, 2013.

**PUBLIC COMMENT:** Lisa Haas stated that she still feels that a web camera will bring more good publicity to Ocean City than any print or television advertising.

**NEW BUSINESS:** Michele Gillian distributed information to the commission for purchasing two information kiosks for the new Welcome Center. A decision will be made on this purchase at the next meeting of the Tourism Commission.

**PUBLIC COMMENT:** Jeff Granahan, Director of the Ocean City Historical Museum, and Holly Kisby General Manager of Shriver's Salt Water Taffy presented a proposal for the Ocean City Tourism Commission to develop a mobile website that provides an opportunity to explore the history of the Boardwalk.

Michele Gillian announced that the Jeep weekend was a success. Many cars were entered and the public really enjoyed this event. Cars were on Asbury Avenue on Friday evening and on the boardwalk on Saturday. Hopefully this event will be held in Ocean City annually.

The next meeting of the Tourism Development Commission will be held on July 25<sup>th</sup> in the Community Room of the Ocean City Library. Charles Bangle suggested that the meeting time be changed to 9:00 am. This was met with approval from the members of the Tourism Commission. The secretary will advertise this change.

Charles Bangle also suggested that the Tourism Commission set their budget for a fiscal year (July 1 to June 30) instead of a calendar year. Michael Allegretto will look into the feasibility of this change.
