Pending Business

- Review of Ordinance 14-34
 - Marty Mozzo discussed this ordinance. He stated that Councilman McClellan had tabled the ordinance at the last Council Meeting of September 25th. Council wanted the Environmental Commission to review what options were available instead of a sod and irrigation paving strip.
 - O Marty opened this up for public comment. Council representatives indicated that they were open to any alternative option which makes sense. The other public attendees indicated that they would like to see native plants instead of the sod in paving strips.
 - Each commissioner gave their opinion and comments on the options available. Native plants still need to be researched and considered.
 - Marty appointed a sub committee to review findings and present to the Environmental Commission.
 - The findings will include criteria for use of native plants in paving strips such as height limitations, as well as some suggested plants which could be used. This will be discussed at the next Commission Meeting.

 - A resolution adopting OSRP as an element of the Master Plan will be introduced and voted on at the Planning Board's October 8th meeting.
 - Once the resolution is adopted, a meeting will be held with the City, Planning Board, and Environmental Commission to discuss the formation of the Open Space and Recreation Committee (OSRC).
