MIDDLETOWN BOARD OF ELECTIONS

OPINION REGARDING

Special Meeting March 3, 2017 3 p.m. Town Hall Council Chambers, 19 W. Green St., Middletown

The Board of Elections is authorized to oversee the election of the Town of Middletown's government pursuant to 15 *Del.C.* §7551(a).

Among its responsibilities, the Board of Elections is to meet and consider whether a complaint concerning any aspect of pre-election action or activity is contrary to state or local election law. The Board is to meet as soon as is practicable and within 24 hours thereof issue a written opinion on whether the complaint has any merit. 15 *Del. C.* §7552(a).

The Board was notified on Tuesday, Feb. 28, by the State Election Commissioner, that there was a complaint made regarding the campaign filings of candidate Jason Faulkner. The Board was notified on Friday, March 3, that a complaint was made regarding the campaign filings of candidates Kenneth L. Branner, Jr. and Drew Chas, citing 15 *Del.C.* §7555(d)(e). The Commissioner's notification to the Board stated that all three candidates did not meet the 7-day filing requirement of 15 *Del. C.* §7555(d), which triggers 15 *Del. C.* §7555(f). "Excepting candidacies otherwise provided for in the town charter and which have complied with the provisions of subsection (d) of this section within 5 days after the election, the Board of Elections of a municipality shall declare a candidate who has failed to comply with the provisions of subsection (d) of this section ineligible to be a candidate and shall order that candidate's name removed from the ballot subject to the appeal provisions of § 7552 of this title. Administrative errors or oversights by municipal or state officials shall not be grounds for declaring a person ineligible to be a candidate."

The Board met in an emergency special public meeting on Friday, March 3, 2017, at 3 p.m., in Town Council Chambers, 19 W. Green Street, Middletown, Delaware, to consider testimony and render a decision. This emergency meeting was necessitated by virtue of the late notices from the State Elections Commission and the pending municipal election on Monday, March 6, 2017. Considering that this hearing was necessary to determine the eligibility of three candidates to remain on the ballot, an emergency meeting was required.

The Board was called to order and after the pledge of allegiance, it heard testimony from Councilman Jason Faulkner who was represented by Greg Morris, Esquire. The Board also heard testimony from Town of Middletown Elections Officer Kristen Krenzer, Mayor Kenneth Branner, Jr. and Councilman Drew Chas. The Board further considered several written documents that were submitted by these individuals.

A. Councilman Faulkner

Mr. Faulkner testified that his declaration of candidacy was received by the State Election Commission on February, 14, 2017. His Statement of Organization was received on February 22, 2017. He stated that he received emailed confirmations that he had filed his documents "successfully". Mayor Branner and Mr. Chas also received emails regarding their successful filings, with no indication that the filings were untimely.

Mr. Morris, representing Mr. Faulkner, raised a concern about the proper method of calculating time under the elections statute. He noted that the General Assembly did not use the phrase "calendar days" in the statute and that there is no guidance to the candidates from the Department of Elections regarding the calculation of time under the statute. When the Campaign Finance Office originally notified Mr. Faulkner that his filing was made on the 8th day, not the 7th, it obviously used calendar days and did not account for an intervening weekend. If the weekend was excluded, Mr. Faulkner's filing was made on the 6th day. Mr. Morris relied on Superior Court Civil Rule 6, which states that when computing time for purposes of applying a statute where the time period is less than 11 days, weekends and holidays are excluded. Hence, applying Rule 6, he argued that Mr. Faulkner's filing was timely.

He also acknowledged that an issue also exists about when the 7-day period is triggered. Is it triggered when the candidate's declaration is filed with the municipality or when it is filed with the Campaign Finance Office? If it is the former, Mr. Faulkner's filing was untimely. Apparently, between the time Mr. Faulkner was first notified that his filing was one day late, the Commission revised its position and now uses the date the declaration was notarized. There is nothing in the statute to suggest that notarization is the triggering event for the 7-day period.

B. Mayor Branner and Councilman Chas

Mayor Branner's declaration was filed with Middletown on January 10, 2017 and emailed to the Commission on January 31, 2017. His Statement of Organization was filed the next day, February 1, 2017. Councilman Chas' declaration was filed with Middletown on January 19, 2017 and emailed on January 31, 2017. His Statement of Organization was filed two days later, February 2, 2017. Hence, the issue regarding their candidacies is when the 7-day period was triggered.

Kristen Krenzer, Elections Officer for the Town of Middletown, testified that she has been in this position for more than 7 years and this is the first year that the statute has come into play. Assuming that there were untimely filings, she feels responsible. The Mayor and the two Councilmen relied on her to handle these filings as a municipal employee. She considers it her oversight, even though she has never been trained or alerted to this requirement by the Campaign Finance Office. Campaign finance matters have traditionally been handled by the State of Delaware, not the Town of Middletown. She testified that she

was directed on January 31 to send the candidate filing forms to the Campaign Finance Office. Ms. Krenzer testified that Mayor Branner and Mr. Chas' declarations were in this batch of filings. She stated she had numerous conversations with the Campaign Finance Office and they readily acknowledged a lack of clarity on this requirement and their lack of administrative oversight on this issue. They commented that other municipalities were also experiencing similar issues for the first time.

After testimony from the three candidates, consideration of the documents presented and argument by Mr. Morris on behalf of Mr. Faulkner, the Board voted unanimously (3-0) that the three candidates in question shall remain on the ballot for the March 6, 2017 general municipal election. This unanimous decision was based on the Board's factual findings that the campaign finance filings were timely based on the proper method of calculating time and using the date the of filing with the Campaign Finance Office as the triggering event for the 7-day period.

In the alternative, had the Board concluded that the filings of the three candidates were untimely, nevertheless, the Board found that this entire situation occurred due to a combination of administrative error and lack of oversight by municipal and State officials. Accordingly, based on this finding, the applicable statute requires that these candidates remain on the ballot.

Motioned by Robert Stewart, seconded by Sonya Comstock. Approved 3-0.
