

**MINUTES of the REGULAR  
TOWN COUNCIL MEETING**

**April 14, 2020 @ 7:00PM  
HELD BY ZOOM TELECONFERENCE  
OCEAN VIEW, DE 19970**

**1. CALL TO ORDER**

Mayor Curran called the meeting to order at 7:00 p.m. with the **Pledge of Allegiance**.

*Present:* Council Members Tom Maly, Frank Twardzik, Bert Reynolds and Bruce White. Town Manager Carol Houck, Finance Director Dawn Parks, Police Chief Ken McLaughlin, Planning & Development Director Ken Cimino, Town Solicitor Dennis Schrader, and Town Clerk Donna Schwartz were present via ZOOM Teleconference.

**2. PUBLIC HEARING**

**A. A First Reading on an Ordinance to establish the Annual Operating Budget for Fiscal Year ending April 30, 2021.**

Mayor Curran briefly explained the ordinance. There was no comment or discussion of the budget by Council or the public.

*A motion was made by Council Member Maly, seconded by Council Member Twardzik, to approve the FY21 Operating budget. A role call vote was taken and the motion passed unanimously 5/0.*

**B. A First Reading on an Ordinance to establishing the revision of the Capital Expenditures Budget for Fiscal Years ending April 30, 2021 -2025.**

Mayor Curran briefly explained the ordinance. There was no comment or discussion of the capital budget by Council or the public.

*A motion was made by Council Member Twardzik, seconded by Council Member White, to approve this ordinance. A role call vote was taken and the motion carried unanimously 5/0.*

**3. ADOPTION of Agenda**

*A motion was made by Council Member Maly, seconded by Council Member Reynolds to adopt the agenda. The motion carried unanimously 5/0.*

**4. APPROVAL of the Town Council Minutes**

*A motion was made by Council Member Reynolds, seconded by Council Member Twardzik, to approve the minutes of the Regular Meeting held on March 10, 2020. The motion carried unanimously 5/0.*

*A motion was made by Mayor Curran, seconded by Council Member Twardzik, to approve and accept the monthly reports. The motion carried unanimously 5/0.*

*A motion was made by Mayor Curran, seconded by Council Member Twardzik, to approve the bid award for paving the parking lot. The motion carried unanimously 5/0.*

**D. Discussion, Consideration, and Possible Voting on a Contract Award for Curb Replacement along Willow Oak Avenue, Project# OV20-0019.**

*A motion was made by Mayor Curran, seconded by Council Member Twardzik, to award the contract for curb replacement. The motion carried unanimously 5/0.*

**7. SWEARING IN OF MAYOR-ELECT REDDINGTON AND COUNCIL MEMBER MALY**

Mayor Curran made some final closing comments and thanked the Council and Staff. Mr. Schrader read the oath of office to Mr. Reddington and Mr. Maly. Following the oaths of office, newly sworn-in Mayor Reddington said a few words and thanked Mayor Curran for his service to the Town of Ocean View.

**8. ELECT MAYOR PRO-TEM**

*A motion was made by Council Member Twardzik, seconded by Council Member Reynolds to nominate Council Member Maly as Mayor Pro-tem. A roll call vote was taken and the motion carried unanimously 5/0.*

**9. NEW BUSINESS**

Discussion, Consideration and Possible Voting on Banking Resolutions Resulting from Change of Mayor.

*A motion was made by Council Member Twardzik, seconded by Council Member White, to approve the banking resolutions for Fulton Bank; Fulton Financial Services (CRIM), WSFS and Raymond James Financial Services. The motion carried unanimously 5/0.*
