

Organizational Meeting Minutes
April 15, 2014

Board of Public Works – A motion was made by Ald. Hutchins, seconded by Ald. Hoogester and carried to approve the Mayoral appointment of Ald. Duquaine as Chairperson for the Board of Public Works.

Finance Committee – A motion was made by Ald. Duquaine, seconded by Ald. Hutchins and carried to approve the Mayoral appointment of Ald. Williquette as Chairperson for the Finance Committee.

Resolution No. 1 – A motion was made by Ald. Williquette, seconded by Ald. Hoogester and carried to approve a resolution designating the public depositories.

City Newspaper – A motion was made by Ald. Kist, seconded by Ald. Williquette and carried 4-3 with Ald. Hutchins, Ald. Duquaine and Ald. Williquette opposed to approve the designation of the Daily News as the official City newspaper.

City Comptroller – A motion was made by Ald. Williquette, seconded by Ald. Duquaine and carried to approve the appointment of Assistant City Administrator Steve Volkert as the City Comptroller.

Board of Canvassers – A motion was made by Ald. Hoogeter, seconded by Ald. Hutchins and carried to approve the appointments by the City Clerk of Amy Ajack and Debbie Geidel to the Board of Canvassers.
